## SUBMISSION OF APPROVED OPERATIONAL & CAPITAL BUDGET FOR THE PERIOD 2007/08 - 2009/10 AND 5 YEAR IDP OF SEDIBENG DISTRICT **MUNICIPALITY**

In terms of Section 24 (1-3) of the MFMA which states the following:

- (1) The municipal council must at least 30 days before the start of the budget year consider approval of the annual budget.
  - (2) An annual budget
    - *must be approved before the start of the budget year;* (a)
    - *(b)* is approved by the adoption by the council of a resolution referred to I section 17(3)(a)(i); and
    - must be approved together with the adoption of resolutions as may be (c) necessary
      - imposing any municipal tax for the budget year; (i)
      - setting any municipal tariffs for the budget year; (ii)
      - approving measurable performance objectives for revenue (iii) from each source and for each vote in the budget;
      - approving any changes to the municipality's integrated (iv)development plan; and
      - (v) approving any changes to the municipality's budget-related policies.

(3) The accounting officer of a municipality must submit approved annual budget to the National Treasury and the relevant provincial treasury."
