Sedibeng District Municipality is requesting bidders to submit tenders for the supply and installation of a backup server solution to the Sedibeng District Municipality. The solution will form part of the current ICT infrastructure and needs to seamlessly integrate with the current infrastructure, software and applications in use. This contract will not be exclusive and will not bind the council to a sole supplier for the term.

1. EXPERIENCE

Companies wishing to tender for this project must have demonstrable experience of the following:

- Familiarity with the role and responsibility of Local Government;
- Supply and delivery of the required hardware; and
- A record of accomplishment in supplying the services as specified in this document.

A complete portfolio including references should be included, demonstrating the ability to deliver, maintain and support the required products in a timely manner.

2. BACKGROUND

The Sedibeng District Council currently operates a majority Hewlett Packard Enterprise brand datacentre. The hardware currently being utilized for the backup systems have reached end of life. This includes both the physical server as well as the tape library.

The Sedibeng District Council intends to replace this hardware with a system that can provide a disk to disk and disk to tape backup capability. At the same time, it requires a system that would incorporate the average growth of the organization and be able to support storage capacity throughout the unit's lifecycle.

The Sedibeng District Council recognises Hewlett Packard Enterprise equipment as a reliable and trustworthy brand that has proven performance and will allow seamless integration into the existing

computing environment. Aligning new hardware with the current infrastructure will ensure unified compatibility and highest performance availability within our datacentre.

The backup application Sep Sesam remains the preferred choice of the Sedibeng District Council and an existing active license agreement is in place.

- 4.2. The Sedibeng District Municipality reserves the right to routinely compare prices quoted for items delivered with the current market prices of other vendors;
- 4.3. Requests for delivery might not be limited to the above stated items only, but the appointed service provider may be required to deliver additional required items other than the items included in the list;
- 4.4. A full service level agreement must be included in the pricing; and
- 4.5. Acceptance of these requirements are mandatory, no variation will be tolerated nor accepted and would lead to the immediately cancellation of the contract.

5. GUARANTEES

- 5.1. All products quoted on should carry a full original manufacturer's guarantee. **Please indicate your compliance with this item clearly.** Failure to comply with the guarantee specification will lead to disqualification of the bid and or contract;
- 5.2. The bidder warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and incorporates all recent improvements in design and materials. 6. DELIVERY

7. DELIVERY TIME-FRAME

- 7.1. Upon the receipt of an official order from Sedibeng District Municipality, delivery and installation of the required products should be within 30 days from the issue of the order.
- 7.2. Repairs orders will be issued via either an official order or an emergency order – depending on the importance of the connection and repairs should be affected within eight (8) working hours to ensure continuance of service delivery to end users.
- 7.3. In the event that delivery cannot take place within the specified period, the vendor is obliged to inform the Director: Information Technology in writing of the possible delay and on his discretion an extension will be granted or the order may be cancelled.

8. ADJUDICATION
