1. PURPOSE

This Request for Quotations has been issued by the Sedibeng District Municipality (Sedibeng DM) in order to procure a service provider to conduct a feasibility study into the aerotropolis sector within Sedibeng District Municipality.

2. INTRODUCTION

The Gauteng Department of Economic Development looks to facilitate the growth and development of the regional economy of Sedibeng District Municipality in order to unlock rapid economic development and job creation.

In pursuit of this, Sedibeng District Municipality looks to appoint a service provider to conduct a feasibility study into the aerotropolis sector within the District. Project completion should comply with all relevant legislation and best practice procedures.

3. PROJECT MANAGEMENT AND REPORTING

The Municipality is required to establish a project steering committee that will comprise of all relevant stakeholders including the Gauteng Department of Economic Development.

4. PROJECT OBJECTIVE
